Since his graduation, he has collaborated with Prof. Raffaele Rascio, full professor of Private Law at the Faculty of Law of the University of Naples, "Federico II". In particular, he has participated in the activities of the aforementioned Chair since **1992**: he carries out together with dr. Nicola Protopisani the seminars to students in the academic years **1992 - 1993 and 1993 - 1994**. He collaborates with Prof. Daniela Vittoria in the development of seminars and tutorials for students of Institutions of Private Law in the academic years **1994 - 1995 and 1995 - 1996**.

With the birth of the Second University, he participates in the academic activities (seminar lessons, exercises, exams and reception of students) of the Chair of Private Law Institutions of Prof. Fernando Bocchini at the Faculty of Law, located in Santa Maria Capua Vetere. In this context, he undertakes to carry out a seminar course, supplementing the lessons of Institutions of Private Law, starting from the academic year **1999 - 2000**. Again at the Faculty of Law of the Second University of Naples - in the year academic year **1999 - 2000**, holds exercises on Institutions of Private Law, on the following topics: - on 19 January 2000: "The interest of the minor"; - on 17 February 2000: "Legal persons and de facto entities"; - on March 9, 2000: "Simulation, indirect and mixed trading with donation"; dated 23 March 2000: "Contracts concluded away from business premises"; dated 13 April 2000: "Jus aedificandi, superficial ownership and elevation right pursuant to article 1127 of the civil code."; dated 27 April 2000: "Easements, distinctions; the easement of landscape". In the academic year **2000 - 2001**, still at the Faculty of Law of the same University, he carried out exercises in Institutions of Private Law on the following topics: - on 9 February 2001: "Legal communion"; - on 16 February 2001: "The object of the legal communion and personal assets"; - on March 9, 2001: "Typical guarantees"; - on March 21, 2001: "The legates". In the academic year **2001 - 2002**, established - at the Faculty of Law of the same University - the teaching of "Integrative Teaching" (of the teaching of Institutions of Private Law) carries out in-depth seminar courses on real rights and real rights limited, dated February 14 and 15, 2002 and February 28 and March 1, 2002.

Since **1997** he has been an expert on the subject (Institutions of Private Law, Family Law and Private Economic Law) of the Faculty of Law of the Second University of Naples.

**In March 1997** he won the competition for access to the interdisciplinary thematic Research Doctorate (private law, history of Italian law, finance sciences, Roman law and history of Roman law), entitled "Private property and public property, current problems and historical precedents", XIII cycle, located at the Faculty of Law of the Second University of Naples. **On 21.12.2001** he obtained the academic **title of PhD cum laude in Civil Law**. Discusses a thesis entitled Privatizations in Italy. Civil law profiles, in which, in particular, the issues of banking foundations and public utilities are addressed. Of the work, the Commission for the final doctoral exam (Proff. Gennaro Franciosi, Domenico Sinesio and Luciano Martone) appreciates the research carried out and the methodologies applied. The judgment is broadly positive and expresses itself as follows: "The research object of the thesis is of great breadth and originality. The methodologies appear perfectly consistent. The results are interesting and analyzed with a predisposition to dogmatic reconstruction and critical sense. In the interview, the candidate demonstrates appropriate argumentation skills and knowledge of the issues addressed".

**In the academic years 1999 - 2000, 2000 - 2001 and 2001 - 2002** he was tutor at the School of Specialization in Law and Economics of the European Communities "Jean Monnet" of the Second University of Naples, in the sector of Community Private Law, also carrying out activities teaching and research.

With the birth of the School of Specialization for the legal professions of the Faculty of Law of the Second University of Naples, he was designated as a professor in the Civil Law sector - coordinated by Prof. Carlo Venditti -. In this context, in the academic year **2001-2002** he was entrusted with a Family Law Module.

In the academic year **2002-2003** he was assigned a module on the dissolution of marriage.

In the academic year **2003 - 2004** he was entrusted with the substitute teaching of Persons Law and Family Law.

**In 2003**, he was the winner of the competition for university researcher in the disciplinary sector IUS/01 - Private Law - organized at the Second University of Naples, School of Law and Economics of the European Communities (later University School for High European Formation "J. Monnet"), in S. Leucio. He takes up service as a Researcher at the aforementioned structure of the University, on 1.12.2003. Within the autonomous teaching structure of the university, in the academic years **2003 - 2004, 2004 - 2005 and 2005 - 2006**, he taught Italian and European civil law and EU private law and family law, in the specialization course established at the said Higher Education School.

He is the winner of the competition for **Associate Professor** in the disciplinary scientific sector IUS/01 – Private law, announced by the Second University of Naples, in the O.G. no. 100 of 12.17.2004, and was called in this capacity by the "Jean Monnet" Faculty of Political Studies and Higher Education of the Second University of Naples, taking up service, on a fixed-term basis, on 3 April 2006. In **the year 2009** he is confirmed in the role of Associate Professor by the national commission.
